**- Philmont Updates**

Mayor Leo Martinez reported on the Governor Michelle Lujan Grisham phased plan and the it is in effect today. This plan allowed for barbershops and acupuncture to open as well as gyms and restaurants to 50% capacity. Mayor commented on the status of Philmont. He stated they were scheduled to meet this last weekend and may have on Saturday but they have not had an employee briefing nor a public statement presented and he added when they do provide an updated report he will have an email sent out to the Governing Body. Mayor Leo Martinez announced that we will be attempting to open Village Hall on June 8, 2020 to the public. He also informed everyone there will be safety directions posted and sanitizer available.

Mayor Pro Tem Laura Gonzales reported she has submitted her final plan for opening up the Library to the public and for the Bookmobile. She also added there will be restrictions when they do open the Library up to the public.

- Councilor Judy B. LeDoux also commented she would like to see traffic slowed down
