# VILLAGE OF CIMARRON REGULAR COUNCIL MEETING MINUTES WEDNESDAY, JANUARY 12, 2022, at 6:00pm

# I. Pledge of Allegiance and to the New Mexico State Flag

Mayor Leo Martinez led the Pledge of Allegiance

### II. Roll Call

### III. Approval of Agenda

Councilor James Gallegos moved to amend the agenda item XIV to include add Mayor report to the minutes- after reviewing the agenda it was determined Councilor James Gallegos had meant to amend the minutes not the agenda.

Councilor James Gallegos then motioned to approve the agenda, Councilor Matthew Gonzales asked to amend the agenda to add Council Concerns back to the end of the agenda and to add discussion item performance evaluations to executive session. This item has been asked to be brought back to the Governing Body every year for review.

There was not a second to approve the agenda

Councilor Judy LeDoux moved to approve the agenda of January 12, 2022, with the two amendments of adding Council Concerns to the end of the agenda and annual staff performance evaluations to executive session. Councilor James Gallegos seconded. Approved 4-0

### IV. Mayor Leo Martinez Comments

Mayor Leo Martinez thanked everyone for attending the meeting. He also explained he was unable to attend the public hearing on Monday as he had some personal business, he had to attend to. Mayor Leo Martinez submitted a written report. Mayor Leo Martinez congratulated the newly elected Council to the Board.

# V. Reorganization of the Governing Body and Staff

### a. Selection of Mayor Pro Tem

Mayor Leo Martinez explained his first initial thought was for Councilman Matthew Gonzales to be the Mayor Pro Tem but with his many things he has going on Mayor explained he needs for the Mayor Pro Tem to be more available. His second choice was Councilman James Gallegos in which he explained he is also out of town a lot and would not be always available. Mayor Leo Martinez made the recommendation of Judy B. LeDoux for the Mayor Pro Tem Position as she is the most available to help if issues come up. He also explained he is fully retired now, and he has more time to spend at the Village but there may be times he needs someone to oversee things if he must be gone. Councilor James Gallegos asked Mayor Leo Martinez if he has checked into nepotism laws in New Mexico? Mayor Leo Martinez responded yes, he did check into this, and it is legal he explained. He also added that so long as there isn't a monetary value it is ok. Mayor Leo Martinez asked for a motion to appoint Judy B. LeDoux as Mayor Pro Tem. Councilor Matthew Gonzales asked just for clarification that he is under the understanding he would not be eligible to vote for Councilor Judy B. LeDoux due to the related relationship. Mayor Leo

Martinez stated that due to the small community issues like this will come up. Mayor Martinez also explained he has correspondence from the NM Municipal League regarding this issue. Admin Shawn Jeffrey left and went to print the email from Lisa Johnston the NMML liaison for the verification of information. Upon the return of Admin Shawn Jeffrey, passed the copy of the email out to each person on the Governing Body, Councilor James Gallegos read the email out loud so the public would have the information as well. The conflict of nepotism is outlined in the email.

Councilor Ernie LeDoux stated he did not run for Council member to abstain from voting, he added he feels it is his civic duty to participate and vote for the betterment of the community. Councilor Matthew Gonzales stated some items need to have discretion and that is the point he was trying to explain.

Mayor Leo Martinez mentioned that Ms. Laura Gonzales will continue to serve as the Cemetery Board president and that the identified improvements are on the ICIP. Funding for the Cemetery improvements project have been submitted.

Councilor James Gallegos moved to approve Judy B. LeDoux for the Mayor Pro Tem Position on the Council. Councilor Matthew Gonzales seconded. Approved 4-0

### b. Appointment of Clerk Administrator

Mayor Leo Martinez made the recommendation of Shawn Jeffrey for the appointment of Administrator.

Councilor Matthew Gonzales asked Mayor Leo Martinez is there has been a resolution to all the issues with the police department that were brought up last month. Councilor Ernie LeDoux mentioned that at the last meeting it was determined that all the theories that were presented at the last meeting were hearsay. Mayor Leo Martinez confirmed the information was hearsay and that nobody was trying to get rid of the police department. Councilor Ernie LeDoux stated the issues were deemed to be hearsay from the last meeting the police report had been submitted, and issues taken care of. He also did say at the last meeting he did observe a poor display of the Council members arguing and it has continued to this meeting. Councilor Ernie LeDoux also added that if Chief Ryan Gates has any issues he should go to the mayor for answers and if the issues do not get resolved they come to Council for information is that correct? He stated there is a chain of command on how things should be working. Councilor James Gallegos asked Mayor Leo Martinez to get control of the meeting and he stated for one council member to reprimand two other council members is out of form. Councilman James Gallegos once again asked for a training on Robert's Rules of order. He stated particularly for Mayor to learn how to run a meeting.

Councilor Matthew Gonzales informed all of the legislative process. Councilor James Gallegos commented that a meeting with the mayor and a couple Council members should be scheduled for this session to ask for Capital Outlay. He also explained the legislative process and how the Governors pork is allocated and how it is allocated separate from the rest of the Capital Outlay. Mayor

Leo Martinez asked if he does schedule a meeting with Governor Michelle Lujan Grisham can both Councilor James Gallegos and Councilor Matthew Gonzales attend?
