a. Mayor's Comments

Mayor Leo Martinez reported that Philmont is moving ahead with the re-opening plan and they are in the process of drafting their strategic plan for the June 1 opening. He thanked Laura Heath Self for making the masks for the Village Office staff. Mayor Martinez also thanked everyone for attending. He also announced that he has been attending the Mayors weekly conference calls and he has another one tomorrow at 2:00pm

b. Village Administrator Report

Did save the Village Hall Improvements project. USDA plans and specs have been approved and once the remaining documents have been approved the funding will be released. We will have enough funding to replace the Euclid crossing done. We do not have enough funding to do any of the others at this time. Mayor Pro Tem Laura Gonzales asked about the election process. Mayor Pro Tem asked when will PWs start to clean up in the Village. Admin Shawn Jeffrey reported that next week they are scheduled to start cleaning up.

He also added that there had been a burglary a few months ago and they are recovering evidence from that incident. Mayor Pro Tem Laura Gonzales asked the status on the speed signs. Chief Ryan Gates reported that they have been ordered and have not been delivered. Councilor Matthew Gonzales thanked the Police Dept. for getting the signs ordered and he asked if now that things are loosening up will they start making more of a presence in the Village? Chief Ryan Gates said they have been patrolling more. He also stated that he has not had a status on his COPS grant. Mayor Leo Martinez added that Andy and Sue Waldin had paid for the signs and the funds had been received. He thanked them again.

a. FY21 Budget Requests

Admin Shawn Jeffrey proposed the Village pay the 3% increase in insurance for the increase in health insurance due to at this time we cannot give any raises to help offset this extra cost. The Council discussed this and will address it at the next special meeting. Councilor James Gallegos replied that he agrees with the proposal for the Village to pay the 3% increase of the insurance. Mayor Pro Tem Laura Gonzales stated at her place of employment they are looking at this issue as well and she mentioned that she does not recall the Village employees receiving their annual evaluations. She also added that she would like to review the budget before the options are decided. Admin Shawn Jeffrey reported that the interim budget will be complete soon.

Mayor Leo Martinez added that the mandate is from the Governor and the Village cannot tell the owners if they can open or if the cannot.

Mayor Leo Martinez explained this variance is temporary until Ms. Aguirre get her new home moved in.

c. Discussion- NM Taxation and Revenue

He asked to reach out to them again and see if we can get some relief – even ask for a total forgiveness. Councilor Matthew Gonzales added that he would like to see a Resolution drafted for this request and submitted to NM Taxation and Revenue for a review. Councilor James Gallegos nominated Councilor Matthew Gonzales to draft the Resolution.

d. Utility Ordinance 277 Amendment - Bulk Water Sales

Mayor Leo Martinez explained that they have in the past sold bulk water to construction companies and also they have sold to citizens who wish to purchase bulk water. Mayor Pro Tem Laura Gonzales mentioned her concern is for the water status- currently the water the reservoir is full but we still cannot pull water from the river. After much discussion the Governing Body mutually agreed to continue to sell water like the process is currently and directed Admin Shawn Jeffrey obtain rates from other Municipalities that sell water. As for the Cemetery there needs to be signage put up that states the water is for Cemetery use only. Amendment of Ordinance for the sale of bulk water to add clauses for water restrictions, availability, possibly put in a minimum and maximum limit of gallons, and price. Discussion only
