### PROCLAMATION PROCLAIMING FRIDAY, AUGUST 13, 2021 AS SPRINGER LITTLE LEAGUE ALL-STARS DAY

**WHEREAS**, the Springer Little League, a Colfax County-based non-profit organization providing baseball programs to youth from Springer, Cimarron, Maxwell, and Roy, has served our communities for decades;

**WHEREAS**, the Springer Little League All-Stars achieved a history-making 2021 season, as two teams played for the District Championships: the 9 & 10 Minors All-Stars and the 11 & 12 Majors All-Stars; and

**WHEREAS**, a Springer Little League Major All-Stars team won the District 8 Championship in 2021, going undefeated in district play, winning the Championship games 30-0 and 16-0; and

**WHEREAS**, the 11 & 12 year-old Major All-Stars went on to compete in the State Championships, representing the first time in the organization's history that a team has achieved this high honor in a single season; and

**WHEREAS**, the Major All-Stars team went 1-2 in State Tournament play, defeating Silver City Little League 17-4, losing to Santa Fe Little League 5-3 in extra innings, and finally losing 4-2 to defending State Champion Shorthorn Little League of Carlsbad; and

**WHEREAS**, the Major All-Stars team included Urijah Martinez, Andrew Gonzales, Rickie Aguilar, Alejandro Villa, Orion LeDoux, Paul Gonzales, Jason Montoya, Alexander Black, Shawn Martinez, Thomas DeHerrera, Rhett Smith, Grant Fudge, coached by Chris Fudge, Brandon Smith & Al Martinez; and

**WHEREAS**, the Village of Cimarron wishes to recognize the hard work and dedication exhibited by the players, coaches and families of the Springer Little League organization, and to celebrate and honor the significant achievements of the teams and the organization;
